## **Cantor Colburn Ranked in the Top 20 of U.S. Trademark Firms Rankings place IP law boutique in the top tier for trademarks issued in 2010**

In 2010 the U.S. Patent and Trademark Office issued 369 trademark registrations for which the firm was counsel of record, representing a 2.5% increase in the number of registrations issued over 2009. Cantor Colburn's jump in the rankings from #34 last year to #20 this year represents a 41% increase. During the same period many firms saw a decline in the number of registrations obtained for their clients.
