Cantor and Krechevsky Nominated to *Who's Who Legal 2016*



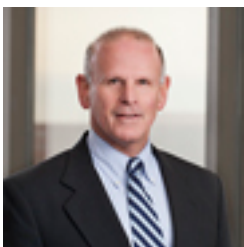
